### What to Know Before Letting Your Horse Out on Trial

**Q: I'm selling my horse. A prospective buyer who rides with a trainer I trust wants to take him on a two-week trial basis. What documentation should I put in place first before he leaves our property?**

**A:** Great question! While two weeks may seem like a short time to some, anything can happen in those two weeks, so you're right to want to have the proper documentation in place.

When considering allowing a horse to go out on trial there are three primary things that I would care about:

**Terms of Use:** Prior to the horse leaving your care, you need to put into writing the terms of use for the trial period. Think about what matters to you: who may ride the horse while it's on trial? If it's a jumper, do you care how high may it be jumped? May it go to a show during that time?

You can think of this documentation much like an abbreviated lease contract, and with that in mind, some things to consider might include:

**Restrictions on use:** This is your opportunity to put into writing anything like the examples listed above. Can the horse go off of the trial trainer's property? Can it go on trail rides?

Owning, leasing, and selling competitive sport horses is a risky business. Even after all the 'I's have been crossed and 'I's have been dotted, things can go wrong for buyer, seller, trainer or all three.

- 1 Be transparent in your bill of sale or lease agreements, noting any lameness issue or special circumstances.

- 3 Always offer the buyer or lessor the opportunity to get an independent veterinarian examination prior to completing the transaction.
- 4 Arrange a trial period with the horse if reasonable.
